Tumorigenic effects have been observed on tests with laboratory animals.

**Subacute to chronic toxicity:**

Resorcinol is primarily a skin and eye irritant. It can be absorbed through the skin especially if carried by a suitable solvent. Exposure may cause edema and lymph gland enlargement, methemoglobinemia, cyanosis, convulsions, tachycardia, dyspnea and death. Local symptoms include hyperemia, itching and dermatitis. Experimental carcinogenic results have been reported.

**Subacute to chronic toxicity:**

The Registry of Toxic Effects of Chemical Substances (RTECS) reports the following effects in laboratory animals:

Behavioral - convulsions or effect on seizure threshold.

Behavioral - excitement.

Behavioral - tetany.

Behavioral - coma.

Blood - methemoglobinemia-carboxyhemoglobin.

Gastrointestinal - changes in structure or function of salivary glands.

Lungs, Thorax, or Respiration - dyspnea.
